NCP Leader To Host Mutton Feast As Meat Ban On I-Day Triggers Political Row In Kalyan-Dombivli

A civic order from the Kalyan-Dombivli Municipal Corporation (KDMC) asking meat shops to shut on Independence Day has snowballed into a heated political controversy, with opposition leaders accusing the administration of "dictating food choices" and threatening to defy the ban. The KDMC notice, signed by Deputy Commissioner (Licensing) Kanchan Gaikwad, mandates all slaughter houses and licensed butchers dealing in goats, sheep, chicken, and large animals to remain closed from midnight of August 14 till midnight of August 15. It warns of action under the Maharashtra Municipal Corporation Act, 1949, if any meat is sold or animals are slaughtered during the period. Explaining the rationale, Gaikwad said the directive follows a longstanding administrative practice of keeping such establishments shut on major national occasions to maintain "public order and dignity" of the day. But the decision has been met with fierce opposition.NCP (SharadPawar faction) MLA JitendraAwhad was among the first to react, terming the move a "blatant attack on personal freedom". He announced plans to host a mutton party on Independence Day as an act of defiance."On the day our country got freedom, you are taking away our freedom to eat what we want," Awhad said. The consolidated results include the financial result of its Indian Subsidiaries (i.e. K Sera Sera Digital Cinema Private Limited, K Sera Sera Miniplex Limited, Birla Jewels Limited, Birla Gold and Precious Metals Limited and step down subsidiary (i.e.KSS E-Commerce Technologies Private Limited earlier known as KSS Speed Technology Private Limited). The Parent Company had defaulted in the conversion of convertible bonds amounting to ₹13 crores issued to Micro Capitals Private Limited. As a result, the condition contained in the agreement was triggered, and consequently, the parent company became liable to make a payment of ₹67,11,69,217/-. The said default occurred on 1st April 2021, during the COVID-19 pandemic, a period during which the Company was undergoing severe financial hardship.

A petition for initiation of Corporate Insolvency Resolution Process (CIRP) under Section 7 of the Insolvency and Bankruptcy Code, 2016 was filed by Micro Capitals Private Limited (Financial Creditor) for the aforesaid default amount of ₹67,11,69,217/-. The Hon'ble National Company Law Tribunal (NCLT), Mumbai Bench admitted the petition vide its order dated 24th January 2023.

Mr. Dharmendra Dhelariya (IBBI Registration No. IBBI/IPA-001/IP-P00251/2017-18/10480) was appointed as the Interim Resolution Professional (IRP) by the Hon'ble NCLT, Mumbai Bench under Section 13(1)(c) of the Insolvency and Bankruptcy Code, 2016. A moratorium under Section 14 of the Code was declared. The Company has continued as a going concern during the CIRP.

In the first meeting of the Committee of Creditors (CoC), Mr. Dharmendra Dhelariya was appointed as the Resolution Professional (RP). The application filed by the RP for approval of the Resolution Plan submitted by Micro Capitals Private Limited was rejected by the Hon'ble NCLT, Mumbai Bench vide order dated 24th March 2025. However, no further directions were issued in the said order. Accordingly, the Resolution Professional has filed an application before the Hon'ble NCLT for initiation of the Liquidation Process against the Company.

Company had received a notice of Demand of Rs 1035.05 Lacs including the interest and penalty under MVAT on account of VAT liability on the leasing of Cinematographic films. Editor's Say 🗷 **'Repackaged Sedition': Supreme Court to Examine Section 152 of BNS**

he Supreme Court has agreed to examine the constitutional validity of Section 152 of the Bharatiya Nyaya Sanhita (BNS), which reintroduces the colonial sedition law. The apex court on August 8 issued notice in a petition that challenges section 152 of the BNS which was previously codified as Section 124A of the Indian Penal Code (IPC). The plea, filed by the Union government on the petition filed by retired Major General S.G. Vombatkere, through advocate S. Prasanna, claims that Section 152 of the BNS has "revived and repackaged" the sedition provisions in the IPC, after the Supreme Court had barred the filing of FIRs under Section 124A of the IPC. "Though the language has been altered, in substantive context, it still criminalises vague and broad categories of speech and expressions as 'subversive activity', 'encouragement of separatist feelings', and acts 'endangering unity or integrity of India'- remains the same or is even more expansive," the petitioner has claimed. Vombatkere was among petitioners who had challenged the validity of the IPC section too. In May 2022, a bench headed by the then Chief Justice of India N.V. Ramana had suspended the usage of the statute, preventing the police from invoking the section against anyone. Justice Ramana had also stayed the probe and trial in existing cases. The court had called for re-examination of the provision. Later in April 2023, a bench led by the then CJI D.Y. Chandrachud had referred the issue to a five-judge bench and asked to decide on the validity of the IPC section.Last year, the IPC came to be replaced with the BNS law but the provision was reintroduced. Many legal experts and activists have raised concerns over the existence of the provision in the statute. The plea points out that, "Section 152 criminalises a wide spectrum of expressive conduct, including those who 'purposely or knowingly' use words spoken, written, electronic, symbolic or financial - to 'excite or attempt to excite' secession, rebellion or subversive activities. Its sweeping language, including phrases like 'encouraging feelings of separatist activities', fails the test of constitutional validity due to vagueness, overbreadth, chilling disproportionate effect, punishment and absence of proximate nexus to public disorder."

World Lion Day: India Celebrates, But How Are Its Lions Really Doing?

t an event to celebrate the day at Gujarat's Barda Wildlife Sanctuary, Union environment minister BhupenderYadav and Gujarat chief minister Bhupender Patel were the main dignitaries on the dais. Today we say with great pride that if anyone wants to see the Asiatic lion, they have to come to Gir in Gujarat," Yadav said, commenting on the increase in lion numbers (from 284 in 1990) to 891 in 2025 - the latter recorded during the latest lion census undertaken by the state government this year. Per the Census and the event of August 10, Barda is now the 'second home' of the Asiatic lion; 17 lions currently live in Barda. On August 10, the Gujarat CM also announced funding of Rs.180 crore to develop the new habitats for lions in the state. An increase in lion numbers, a new home for lions, and funds to the tune of Rs.180 crore - all paint a glowing picture of India and its Asiatic lions. But how are India's lions really doing?Conservationists are not very impressed. Scientists told The Wire that while the Asiatic lion population in Gujarat may have indeed risen, the use of out-dated and flawed methodology in the latest lion census means that its findings need to be taken with a dollop of salt. Meanwhile, even though Gujarat is setting up a 'second home' in the state for lions at Barda Wildlife Sanctuary, this will not be ideal because it is just around 100 km from Gir, biologists told The Wire. And Gujarat still refuses to part with its lion prides. Despite a Supreme Court order in 2013 that some lions should be relocated into Kuno National Park in Madhya Pradesh, nothing has moved. While cheetahs have come into Kuno all the way from Africa, India's Asiatic lions still do not have a home in another state in their own country. This could affect their survival. With the entire population of Asiatic lions being located exclusively in Gujarat, a single disease outbreak could easily wipe them out, biologists say. News reports have recorded a few recent lion deaths too.

A looming threat

Single population species - or species that survive in only one natural population in a single, isolated geographic area - are at a huge risk of extinction. A prime reason: disease. A single major disease outbreak such as a virus - could wipe out such isolated single populations of species very quickly, coupled with other existing threats such as persecution by people, climate change and habitat loss. These fears are justified because this has happened in the past. The Christmas Island Rat, a rat native to the Christmas Island in the Indian Ocean and found only there is thought to have gone extinct between 1898 and 1908, after contracting parasitic protozoans called trypanosomes from black rats (that came to the island accidentally as stowaways on expedition ships). The Asiatic lion which dwells in Gujarat, however, is technically not a separate species of lion from their cousins in Africa. They're a separate sub-species: which means they are not different enough to be called a different species, but distinct enough – both physically and genetically - to be a different subspecies. And Gujarat's Gir is the Asiatic lions' onlyhome. Recent Asiatic lion deaths in the district of Amreli in Gujarat have worried conservationists. In late July this year, news reports recorded the death of three lion cubs in Amreli; forest authorities have kept six

observation. In 2018, a combination of several health concerns including canine distemper - caused by a highly communicable virus - and a protozoal infection had killed more than 30 lions in Gujarat in a month's span. Early this year, the Gujarat state government said in the Gujarat Assembly that 286 lions including 143 cubs had died between January 2023 and December 2024. At least 58 lions and 17 cubs died unnaturally, reported The New I E."It is prudent conservation practice based on strong scientific foundations not to have all members of an endangered species existing at a single site," commented big cat biologist Ravi Chellam, who has been involved with lion conservation since 1985. "Any catastrophe natural or human-mediated can in a very short span of time wipe out the hard-won conservation success and lay to waste several decades of work, if all surviving members of an endangered species are restricted to a single population. The risks are numerous include habitat fragmentation, degradation and destruction, cyclones, floods, forest fires, disease outbreaks, political decisions, droughts, poaching, violence and wars," Chellam said.

Rising numbers, expanding ranges

On May 21 this year, Gujarat CM Patel announced results from the latest census of Asiatic lions. Their number has risen from 674 to 891 in five years, he said. The Census document claims that lion populations have also expanded their range (35,000 sq km now, an increase by around 16% when compared to 2020). "I suppose there is some merit in this claim. From the available information including maps, it looks like they have computed this area by joining the locations of the lion sightings farthest from Gir," commented Chellam.Per the Census, nearly half of the lion population (44%) has been observed in "non-forest areas" wasteland, agricultural lands, riverine areas and near human habitation. The bulk of this area where the expansion of Asiatic lions has occurred is human-dominated areas including cities and towns which are not very suitable for lions to inhabit, Chellam said."It does throw up challenges," Chellam commented. "People's lives are disrupted and the lions are also under stress. There are reports of lions turning aggressive and attacking people. There was a recent report of a man being attacked and killed by lions. This is bound to happen especially since people approach the lions closely on foot and often harass the lions. In fact, it is a miracle that the number of attacks are so low, given the extremely frequent interactions and the resulting opportunities for lions to attack people."On June 25, a lion dragged a fiveyear-old from a farm near Thordi village near Savarkundla range in Amreli district. The bov. who was mauled in the attack, died. The state forest department captured the lion and moved it to a rescue center, according to a report by the Press Trust of India. The latest Census recorded the presence of lions for the first time in Amreli: the district did not host lions before. Again in Savarkundla, forest department watchers found the body of a partially-eaten man in March this year. This came just a week after Amreli witnessed a lion kill a farmer, drag his body away and sit on it refusing to let go until forest officials

Flaws in census methods



Most people do not look beyond the main result of the latest lion census - that lion numbers have increased. Prime Minister NarendraModi too raved about this rise. In his 122nd episode of Mann Ki Baat on May 25, he said: "This number of lions that emerged after the lion census is very encouraging. Friends, many of you must be wondering how this animal census is conducted! This exercise is very challenging. You will be surprised to know that the Lion Census was conducted in 11 districts, in an area of 35 thousand square kilometres. For the census, the teams monitored these areas round the clock... twenty four hours. Both verification and cross verification were done in this entire campaign. This enabled the counting of lions to be completed with utmost precision." But there's more to the Census - and it turns out that "precision" may have been the last thing that the exercise involved. While the Asiatic lion population may indeed have risen, scientists who have studied both the Asiatic lion as well as methods to accurately estimate big cat populations across the world - including African lions – told The Wire that the outdated and flawed methodology in India's lion census leaves much to be desired. The methodology employed to count the Gir lions falls within the broad category of 'index-based methods' in wildlife abundance estimation literature, scientist ArjunGopalaswamy, told The Wire. Gopalaswamy is the founder and chief scientist of Carnassials Global, an organisation that provides science advisory services to governments, universities, etc. in Africa and Asia, and has co-authored studies on population estimation of big cats including tigers in India, African lions in Uganda and South Africa and African cheetahs in Kenya. This category of 'index-based' methods is now considered outdated, as it fails to account for detection probability, rendering the information generated by such surveys unreliable, Gopalaswamy said. Detection probability is the probability that observers detect signs of an animal in an area, if it is present there. "Consequently, any perceived changes in abundance are also unreliable," Gopalaswamvadded.The latest "contemporary and robust approach" to counting lions relies on obtaining unambiguous individual identities, he said. This is now done predominantly through direct photography and complemented by other field methods. Moreover, this has to be done "within a rigorous spatial capturerecapture framework", Gopalaswamy added. Spatial capture-recapture means a photo capture system where a region is divided into smaller blocks, or grids, and camera traps are deployed in these areas over a fixed amount of time taking into account the home ranges of lions. The number of lions here is then estimated using mathematical models, based on the number of times a specific individual was "caught" and "recaptured" by the camera traps. "This approach has been successfully implemented at large scales across several countries and specific sites in Africa," Gopalaswamy said. This is the same method that India too uses to estimate its tiger numbers. So why isn't this more advanced and scientifically more robust technique being used to count lions? Because India does not use this method for lions yet, it "significantly lags behind many countries and sites in Africa in the scientific estimation of wild lion populations", Gopalaswamy said. Even big cat biologist Y.V Jhala who was formerly with the government-run Wildlife Institute of India has been cautious about the numbers presented in the lion census. He told Al Jazeera in June this year that a "total count of wide-ranging wild carnivores is not a scientific way of estimating their population". Why does this matter?

Firstly, it raises questions about the validity of lion population estimation numbers that India is proudly celebrating. And secondly, bad science can be deleterious for both people and wildlife - because this can influence conservation action in several ways."An emerging trend of concern is that changes in lion numbers, based on unreliable index-based methods, are being adopted uncritically in IUCN assessments, including the Red List and Green Status List," Gopalaswamy said. "Worryingly, these trends are also being incorporated into scientific manuscripts without adequate questioning."

A second home for India's lions? Biologists including Chellam have recommended time and again that Gujarat relocate some of its Asiatic lions to another site away from Gir to ensure that another. standalone population thrives in another location. But the Gujarat state government has resisted these suggestions, and even orders to this note from the Supreme Court. In April 2013, the Supreme Court had ordered that a few lions be translocated from Gir to Kuno within six months. But Gujarat has refused to share Asiatic lions with any other state so far. It is important to not forget that translocating lions to Kuno is "the law of the land" because of the Supreme Court order, Chellam added. "It is well over twelve years since this order was passed and tragically, everyone concerned has chosen to ignore this order of the Supreme Court of India."In this regard it is "disappointing" to see the "levels of impunity" with which the State Government of Gujarat and also the Government of India have been operating at, he said. The governments are now setting up Barda as a 'second home' for the lions - but it is not ideal, Chellam commented. "Barda, as the crow flies, is less than 100 km from Gir, small in size (less than 200 sq.km), with a very low-density prey population and hence unsuitable to host a viable population of lions," Chellam cautioned. The whole point in translocating a few lions to establish a second free-ranging population of wild Asiatic lions outside Gir is to ensure geographical isolation, he added. This geographical isolation is necessary to mitigate the risks of having the entire population of an endangered species as a single population. "Conservation of lions and in fact, most species, doesn't require astronomical budgets," Chellam noted "What is required is knowledge-based plans which are implemented in a transparent. inclusive and accountable manner. Harping on Barda as a second home is merely a distraction and a delaying tactic to continue to stall the translocation of lions to Kuno."by-Aathira Perinchery.

Shah, and former member of group of interlocutors for Jammu and Kashmir Radha Kumar - in its recently released report has placed the blame entirely on the NarendraModi government for the "return of cross-border militancy" in Kashmir. "The Union Home Ministry's policy of placing non-State officers ('outsiders') to helm civilian security and governance" and "jettisoning of experienced local officers" that followed as a result of the NarendraModi government's unilateral decision to reorganise Jammu and Kashmir as a union territory and concentrate power in its own hands "entailed a paucity of intelligence from the ground and contributed to the security lapses that allowed cross-border militancy to return to the PirPanjal and Chenab valley areas of Jammu from 2020-2021 on, and then allowed it to spread to Kashmir...," the report states. "It contributed, too, to the failure to prevent the Pahalgam terrorist attack," it adds. The 2025 report is the sixth annual report released by the FHRJK, which was formed after the Union government diluted Article 370 and reorganised Jammu and Kashmir. Compiled on the basis of government sources, media accounts, NGO fact-finding reports, interviews and information gathered through legal petitions, the report notes that in spite of the assembly elections in September-October 2024, the people of the union territory continue to feel disempowered.It issued by the Union home ministry on July 12, 2024, months ahead of the assembly elections, ensured that the Union government retained most of the administrative powers in J&K through the Lieutenant-Governor and held control over "civil servants, the police, the Attorney-General, and prosecutorial services". The report states that the extent of the Union government's control could be gauged from the fact that soon after the Omar Abdullah government came to power with a comprehensive majority, the L-G returned his proposal for "allocation of portfolios to Ministers and establishment of a mechanism to resolve difference of opinion between the and centrally appointed administrations, with queries as to whether it was in accordance with the Jammu and Kashmir Reorganisation Act of 2019."It further notes that post-Pahalgam attack, the situation has worsened in J&K, as despite the fact that Kashmiri people condemned the Pahalgam attack and repudiated the terrorists goals to foment Hindu-Muslim polarisation and instability, the police investigators hastily announced the involvement of two Kashmiris in the attack, only to retract later. However, in the meantime, the evidence-less declaration resulted in a pan-India backlash against Kashmiris, the report says. "Allegedly, over 2,800 people have been detained or summoned for questioning and over 100 have been arrested under the draconian Public Safety Act (PSA) and Unlawful Activities Prevention Act (UAPA). There are daily cordon and search operations as well as raids; continuing purges of local officers; intimidation of the media, and other scantily verified or unjustified harassments detailed

the report says, adding that "the post-Pahalgam environment, which was widely conducive to the re-establishment of peace building initiatives, is thus already being vitiated."The report goes on to recommend that such "vitiation of civil and political rights, including oversight institutions" can be contained only by granting the promised statehood to the union territory. Yet, there are still no signs by the Modi government of "fulfilling its promise", even after several MPs demanding restoration of statehood in J&K in the run-up to the monsoon session of the parliament. The forum has demanded a rollback of the Jammu and Kashmir Reorganisation Act, 2019, and an immediate discussion between Ladakhi representatives and the Union government on demands of Ladakh's statehood and its incorporation in the Sixth Schedule, too.

Pahalgam security lapse

The report found that there was "a major security lapse by the Lieutenant-Governor's administration and the Union Home Ministry" in the case of Pahalgam terror attack. The report confirmed that intelligence warning of an attack was "received in actionable time" but the security reviews were both "feeble and incompetent".A Central Reserve Police Force (CRPF) picket close to the Baisaran meadow, where the attack took place, was removed in January, 2025, the report notes, and was not reinstated even after intelligence inputs about a possible attack. Further, the FHRJK found that "the responsibility of Union home minister Amit Shah remains to be acknowledged" as he "personally supervised repeated security reviews following the intelligence that an attack was being planned". The report also holds the Union



gvoernment accountable for not preventing a backlash against Kashmiris in various parts of India and allowing hate speech and hateful actions against them in the aftermath of Pahalgam terror attack. The FHRJK expressed concern about Pakistani military response to 'Operation Sindoor" that it thought "revealed a new level of China-Pakistan defence cooperation" that included not only supply of arms but also "onsite guidance by Chinese military-strategic personnel". This, the report says, deviates from China's earlier stance of noninvolvement in the India-Pakistan conflict, and can add to India's challenges in the context of "China's encroachments in Ladakh". Despite the Union government increasing expenditure on security in J&K, amounting to Rs 1347.79 crores, the FHRJK believes that merely enhancing security measures could be ineffective as the Pahalgam incident showed. and past lessons counterinsurgency are being ignored. As our own experience has repeatedly shown, armed attacks dwindle only when the local people and their elected representatives are involved in peace building on the ground, and when security forces are seen to adhere to the human rights guidelines laid down by the Supreme Court in 1997, which were included in the Indian Army's 'List of Dos

and Don'ts' under the Armed Forces (Special Protection) Act," the report says. Apart from pressing for restoration of statehood for J&K and Ladakh, the FHRJK recommended opening а dialogue between parliamentarians and members of legislative assembly on the special status of J&K and reinstating J&K's oversight commissions like the Human Rights Commission, the Women's Commission, the Accountability Commission and the Information Commission which were shut down after Article 370 was hollowed out. She further tightened her grip on the game as the scoreline read 7.5-1.5 in her favour after the second segment.Last month, Divya defeated compatriot Koneru Humpy in the finals of the Women's World Cup for her biggest victory in her career.R Vaishali, the other Indian in the field, was eliminated after losing 6-8 to US IM Alice Lee last week. Chinese GM JuWenjun is the reigning women's speed chess and Indian GM D Gukesh is the reigning Junior Chess Champion.The Chess Championship is an online singleelimination event featuring 16 players, comprising eight qualifiers and eight direct invites, competing

Trump's Ukraine 'Territory Swap': What The Deal Could Look Like On Map Vs Reality On Ground

Moscow, (Agencies):

The announcement of a Donald Trump-Vladimir Putin summit in Alaska on August 15 has brought a contentious idea to the fore: a potential "territory swap" in Ukraine in exchange for a ceasefire. The proposal, as reported by CNN after US special envoy Steve Witkoff's recent Moscow visit, would see Kyiv cede remaining parts of Donetsk still under its control to Russia in return for halting the fighting freezing the current elsewhere.Donetsk and neighbouring Luhansk lie in eastern Ukraine along the Russian border. Together they form the Donbas region, a flashpoint since 2014 when Moscow-backed separatists seized parts of both provinces. Those areas remained under rebel control until Russia's fullscale invasion in 2022, after which Moscow declared the "liberation" of additional cities and claimed the entire region as annexed. While the United States hopes the meeting could pave the way for an end to the war. the notion of trading land for peace has already been rejected outright by Ukraine and has triggered deep unease in towns

that would be directly affected. What Is The Territory Swap Idea?

According to CNN, the Kremlin's pitch to Witkoff included an offer to exchange a ceasefire for territory in Donbas that Russia has not yet conquered. For Moscow, the aim is to consolidate its hold on Donetsk Luhansk. and completing its long-sought control over the industrial heartland — a region rich in coal, heavy industry and infrastructure that has been at the centre of conflict since 2014. Trump has previously said both sides would need to cede territory to end the fighting, remarks that reinforced Kviv's fears the US could seek to impose a deal over Ukrainian objections. The scenario most frequently discussed would see Ukraine withdraw from the remaining areas of Donetsk it controls, with Russia halting its offensives in Zaporizhzhia and Kherson and accepting a frozen line of contact.For Kviv. this would mean surrendering towns it has fought to hold and that residents have struggled to rebuild, while legitimising Russian gains from an invasion that began in 2022. For Moscow, it would formalise battlefield progress and allow it to declare

victory in the Donbas.

On the ground, the reaction is one of disbelief, defiance and anxiety. CNN reported from Sloviansk, a city first seized by Moscow-backed separatists in 2014 and retaken by Ukraine later that year, that residents are living with regular shelling and the proximity of the eastern front.On the beaches of the town's tiny salt lake, where locals seek relief in medicinal waters under the shadow of a concrete bomb shelter, talk of a land deal feels surreal.Local journalist Mykhailo told CNN he calls the place "the Salt Lake City of Sloviansk" and said the rumours have caused "panic" among friends who fear they will be forced to leave again. "Many of my friends want to stay here... but frankly speaking I don't

think it is going to happen,"

hesaid. The idea that their key ally, the United States, could contemplate handing their town to Moscow is particularly jarring. New trenches have been dug west of Sloviansk in case Russia's offensive pushes closer, but few imagined that the risk could come from a political bargain rather than a battlefield

are still shifting, and in places, moving in Russia's favour. The Donetsk region, central to Moscow's demands, is seeing some of the fiercest fighting of the summer. Control over key hubs like Pokrovsk and Kostiantynivka, major logistics transport nodes, is vital; losing would complicate Ukraine's ability to supply and reinforce troops defending the rest of Donetsk. Sloviansk, one of the largest cities in the Ukrainian-held part of Donetsk, is close enough to hear shelling daily. Just 20 kilometres away, the nearest train station in Kramatorsk bustles with soldiers heading to and from the front, and civilians trying to evacuate or return home. Air raid sirens greet trains arriving from Kyiv, underscoring that even Ukraine's rear areas remain under threat.For many residents, the strategic maps debated in distant capitals feel irrelevant compared to the immediate risk to loved ones. A woman named Tetvana told CNN she had travelled to see her husband, a tank unit soldier, for just two days to mark his birthday. "I just want my husband to be alive and come home," she said. The prospect of a political deal trading away nearby territory doesn't factor into her calculations, survival

Trump's Position And

Leverage From the start of his presidency, Trump has called for a 30-day unconditional ceasefire as the prelude to peace talks. Ukraine accepted this in March; Russia did not. Since then. Moscow has escalated, with attacks described as having doubled since Trump entered office, according to CNN.In recent weeks, Trump has sought to increase pressure on Putin. He unveiled a policy linking failure to accept a ceasefire to escalating sanctions not just on Russia but on buyers of Russian energy — a move that has already led to increased tariffs on India. He has also reaffirmed continued US military support to Ukraine via NATO allies and highlighted allied commitments to increase defence spending. These moves, coupled with Russia's heavy military losses, form the basis of the White House's argument that Trump arrives in Alaska from a position

of strength. The Reagan Parallel

In October 1986, US President Ronald Reagan met Soviet leader Mikhail Gorbachev in Reykjavik, Iceland, to explore ways to ease Cold War tensions and cut nuclear arsenals. The talks came close to producing a



when Gorbachev demanded the

US abandon its nascent missile defence programme, something the Soviets saw as a threat to their deterrent. Reagan refused, and both leaders walked away without an agreement. At the time, it was widely labelled a failure. Yet that refusal to compromise on a core principle is now seen as pivotal. Within a vear. Washington and Moscow signed the first treaty eliminating an entire class of nuclear weapons. By 1991, the two powers had agreed to sweeping arms reductions, all while the US continued developing missile Revkjavik remembered as a moment when walking away set the stage for a better deal later. For Alaska, the comparison lies in the negotiating stance. The logic is that Trump should insist on his declared condition - a full, unconditional 30-day ceasefire - before entertaining any maps. swaps or political concessions. Agreeing to a territory swap without first silencing the guns could entrench Russia's battlefield gains, legitimise its claim to the rest of Donetsk, and allow it to rearm for future offensives. As in 1986, leaving without a deal might look like failure in the moment but could strengthen the chances of a more durable

Why Ukraine's Absence At The Table Raises Concerns

The Alaska summit is being without Ukraine's held participation, a fact that adds another layer of controversy to any talk of territory swaps. The risk is that a meeting between Trump and Putin, complete with maps in hand, could produce the image Moscow covets — the US and Russia sketching out future borders of a European country that Russia invaded, all without that country's consent. Kyiv has repeatedly stated it will not accept any settlement that cedes territory, and being excluded from talks raises fears that decisions about Ukraine's future could be made without its involvement. The sequence that avoids this risk is straightforward: secure a ceasefire first, bring Ukraine in as a full participant for political negotiations second, and only then move to detailed discussions on borders or territorial arrangements.

Could A Ceasefire Work? Trump's proposal for a 30day unconditional ceasefire is meant to be a quick test of Moscow's intent. Supporters of the idea point to immediate gains: stopping artillery and missile attacks could save lives in towns like Sloviansk, Pokrovsk and Kostiantynivka, which are under near-daily humanitarian corridors could be opened to evacuate civilians and deliver medical supplies; and damaged infrastructure could be repaired without the risk of shelling.A workable ceasefire would require detailed terms: halting offensive ground movements, banning strikes beyond the current line of

however, are not theoretical. If it is simply pause without political progress, it risks becoming just another chapter in a grinding

The Bottom Line

The proposed territory swap is not a neutral bargaining chip. It represents the possibility of formalising Russia's gains in Donbas, forcing tens of thousands from their homes. and undermining the principle that borders cannot be changed by force. On the ground, it injects uncertainty fresh communities already living on the edge of conflict.In Alaska, the outcome will likely be binary: either Putin agrees to a full ceasefire as a starting point, or the summit risks ending with the war continuing and the frontline unchanged, except for the psychological blow to those wondering if their homes will be traded away.

The 71-vear-old movie star who started his career as a stuntman before turning to acting has admitted he always gets nervous before filming a big scene and regularly worries that he will meet a nasty end if an ambitious action sequence goes wrong. During an appearance at the Locarno Film Festival in Switzerland, he explained: "I'm no Superman. I am scared. Before a stunt, I go: 'Am I going to die this time?'"Chan went on to insist he's still capable of doing he's in his 70s and he always wants to make his movies the best they can be. The Hindi film industry has predominantly catered to the sensibilities of the privileged and kept its stories detached from social questions. The sanitised urban aesthetic charm of an apolitical GenZ has been given growing acceptability in Hindi films and conveniently sidelined the lived realities of the margin.In fact, popular narratives against the socially marginal assertions for equality, liberty and justice cinematic representations while politics of identity assertions and social justice are abandoned. In the last few years, with the rise of right-wing political and cultural forces, more and more

Immediately, in the next scene, there is an attempt on the man's life by a delivery man who was angered by the Dalit political assertion and an intercaste relationship. Later the delivery guy turns out to be an



upper-caste contract killer. Shankar, a self-styled advocate of caste purity. Dhadak 2 is released at a time when Dalits are mourning the dishonour killing of Tamil Dalit youth KavinSelva Ganesh for being in an inter-caste relationship with a dominant caste woman. In contrast to these tragic realities. Neelesh survives in Dhadak 2, despite quite a few attempts on his life by Vidhi's lawver father to uphold the gene'. Most surprisingly, Iqbal has created spaces for Ambedkar throughout the backdrop of the film, and slowly yet steadily centred the film on Dalit dignity, Ambedkarite politics on

campus and Dalit rage against

casual casteism. What stands out in the film is director's conscious attempt empowerment and giving agency to Vidhi. She constantly Brahminical patriarchy at home, at family gatherings and in the law university campus.lt was heartwarming to see how lqbal has recognised Dalit women's sociopolitical agency and acknowledged Dr Ambedkar's role in it. Neelesh's mother is a staunch Ambedkarite woman who is seen to be encouraging her son after he faces police brutality and custodial torture. She quotes the iconic example of Dr Ambedkar to encourage Neelesh to study law, telling her son, "Babasahebko koi

haatnehilaagapaya, kyukiwoh barrister tha' (Nobody could do Babasaheb anything to because he was a barrister).

The urgency of Ambedkarite politics on campus

Dhadak 2 has not missed a single chance to capture growing Ambedkarite politics and anti-caste awareness to counter casteist notions of merit and anti-reservationists on the Indian higher education campuses, especially after the institutional murder RohithVemula. Igbal's nuanced understanding of campus politics is remarkable. Dhadak 2 has captured the scholarship crisis, issue of disbursals and how that brutally affects SC/ ST/OBC students. Iqbal's portraval of Shekhar, an Ambedkarite activist and leader of the Ambedkar Students' Union on a national law university campus, is well thought out and an embodiment of Kanshiram's 'bhagidari politics' and Bhim Army chief Chandrashekhar's politics of radical Dalit assertion against the right-

wing

caste

Hindutva

subsequent isolation of Shekhar and his comrades on campus is also imagined through Vemula's politics against institutionalised caste discrimination. The film goes beyond the traditional reductionism, and is focused heavily on Dalit empowerment and upliftment and nurturing women to take up the project of annihilation of caste. Vidhi is Dimri's strongest character yet, as Neelesh is Chaturvedi's. Through Dhadak 2, the director has ensured three critical shifts in making caste-centred for the films future: interrogation of caste privilege; nurturing upper-caste women to outrage against the Brahminicalcasteism patriarchy in both private and public spheres; and confronting caste-based hostilities with an empowered voice. Dhadak 2 ticked almost all the checkboxes, but fell short in avoiding stereotype of the Dalit face. Darkening and tanning Chaturvedi'sface was nor

'Dalitness'. Bollywood needs Dalit directors, producers and that actors. so representation is ensured through self-esteem and lived experiences. Though the film is an adaptation of Mari Selvaraj'sPariyerumPerumal, it goes beyond the original on many occasions in terms of empowering the characters, but falls a little short in bringing Ambedkar from background to the forefront of discussions. Despite this, Iqbal should be lauded for projecting Ambedkar as an emancipator throughout her film. From naming Neelesh's band the 'Bhim Baaza Dhol Boys' to calling the Dalit slum 'Bhimnagar', it was a strong message delivered. Dhadak 2 is a radical anticaste project. Iqbal's well thought through direction will be reckoned with in Bollywood and regional film industries like Tollywood in the days to come. It's depressing that the film like this couldn't generate much discussion and debates among the young, as they remain engulfed in Saiyaara.by-Subhajit Naskar.


